Background:	IRAK1 encodes the interleukin-1 receptor-associated kinase 1, one of two putative serine/threonine kinases that become associated with the interleukin-1 receptor (IL1R) upon stimulation. The exposure of HeLa cells or human embryonic kidney cells overexpressing IL1R to IL1 caused rapid association of IRAK with the IL1R complex and phosphorylation of IRAK (1). IRAK1 is partially responsible for IL1-induced upregulation of the transcription factor NF-kappa B. IRAK1 as a risk gene with critical role in the pathogenesis of systemic lupus erythematosus (2). IRAK1 Protein is ideal for investigators involved in Signaling Proteins, Cellular Proteins, Inflammation, NfκB Pathway, and p38 Pathway research.

Application Note:	IRAK1 Protein is stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol. IRAK1 Protein is suitable for use in Western Blot. Expect a band approximately ~74kDa on specific lysates or tissues. Specific conditions for reactivity should be optimized by the end user.
