Background:	The GABA-A receptor is a member of the superfamily of fast acting ligand-gated ion channels. The individual subunits of these receptors have similar sequences and structural features. GABA-A receptors are the major fast inhibitory neurotransmitter gated ion channels in the brain.

Purity/Specificity: Anti-GABA-A receptor delta Antibody was purified by Protein G chromatography. A BLAST analysis was used to suggest cross-reactivity with GABA-A receptor delta from mouse and rat based on 100% homology with the immunizing sequence. No cross-reactivity against GABA-A-R-Beta 2 or -Beta 3. Cross-reactivity with GABA-A receptor delta from other sources has not been determined. Ion Channels research.

Tested Applications: IF, WB

Application Note: Anti-GABA-A receptor delta Antibody is tested for use in WB and IF microscopy. Expect a band approximately ~55kDa on specific lysates. Specific conditions for reactivity should be optimized by the end user.

Assay Dilutions: All assays should be optimized by the user. Recommended dilutions (if any) may be listed below.

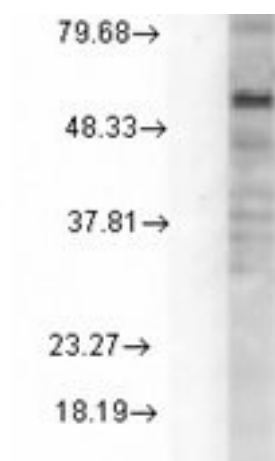
Shipping & Handling

Shipping Condition: Dry Ice

Storage Condition: Store vial at -20° C prior to opening. Aliquot contents and freeze at -20° C or below for extended storage. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.

Expiration: Expiration date is one (1) year from date of receipt.

Western Blot of mouse anti-GABA-A Receptor Delta antibody. Lane 1: Rat cell line mix. Load: 15 µg per lane. Primary antibody: GABA-A Receptor Delta antibody at 1:1000 for 2hr at RT. Secondary antibody: Sheep Anti-mouse HRP secondary antibody at 1:10,000 for 60 min at RT. Block: 1.5% BSA for 30 min at RT. Predicted/Observed size: 50.6 kDa, ~53 kDa for GABA-A Receptor Delta. Other band (s): none.
