Background:	Depolarization-activated potassium channels (Kv) play a major role in shaping the electrical signals in the nervous system. KvBeta1.1 is expressed abundantly in rat brain, and is known to induce inactivation of the delayed rectifier channel Kv1.1 and Kv1.4Delta1-110.

Purity/Specificity: Anti-KvBeta1.1 K⁺ channel Antibody was purified by Protein G chromatography. A BLAST analysis was used to suggest cross-reactivity with KvBeta1.1 K⁺ channel from mouse, human, and rat based on 100% homology with the immunizing sequence. Does not cross react with KVbeta1.2, 1.3 or 2. Cross-reactivity with KvBeta1.1 K⁺ channel from other sources has not been determined. Ion Channels research.

Tested Applications: IHC, WB

Application Note: Anti-KvBeta1.1 K⁺ channel Antibody is tested for use in WB, IP, and IHC. Expect a band approximately ~44kDa on specific lysates. Specific conditions for reactivity should be optimized by the end user.

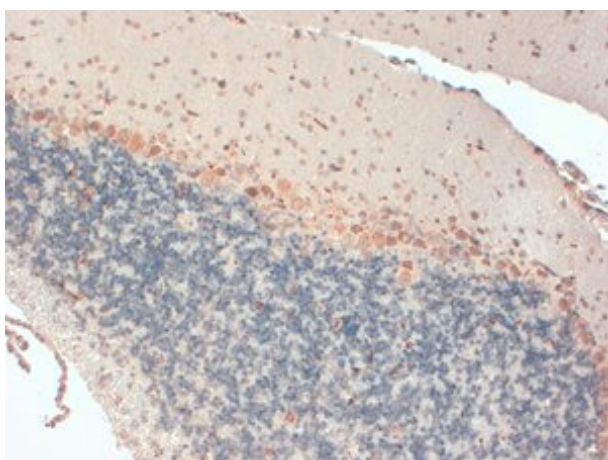

Shipping Condition: Dry Ice

Storage Condition:	Store vial at -20° C prior to opening. Aliquot contents and freeze at -20° C or below for extended storage. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.
Expiration:	Expiration date is one (1) year from date of receipt.

Tissue: Mouse Brain extract. Primary Antibody: KvBeta1.1 antibody at 1 µg/mL for 1h at RT. Secondary antibody: Peroxidase mouse secondary at 1:10,000 for 45 min at RT. Localization: Cytoplasm. Staining: KvBeta1.1 as brown signal.
