Background:	ERK2 antibodies detect the ERK2 isoform. Mitogen activated protein kinase 1, also known as MAPK1, ERK, or ERK2, is an integral component of the MAP kinase cascade that regulates cell growth and differentiation. ERK1 and ERK2 are activated by MEK1 and MEK2 in the B-raf signaling pathway resulting in its translocation to the nucleus where it phosphorylates nuclear targets. Human ERK1 and ERK2 are 84% identical in sequence and share common functionality in cells. Anti-ERK2 antibody is ideal for investigators involved in Neuroscience, Cell Signaling and Cancer Research.

Anti-ERK2 is purified from tissue culture supernatant by protein A purification. Cross reactivity is expected to occur with human, mouse, and rat based on sequence identity of the peptide immunogen. This antibody does not react with the ERK1 isoform.

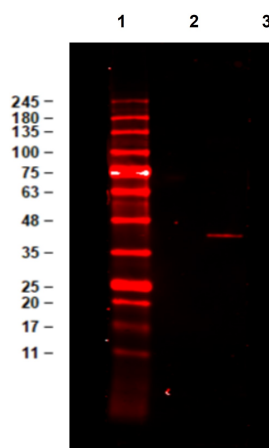

Storage Condition: Store vial at -20° C or below prior to opening. This vial contains a relatively low volume of reagent (25 µL). To minimize loss of volume dilute 1:10 by adding 225 µL of the buffer stated above directly to the vial. Recap, mix thoroughly and briefly centrifuge to collect the volume at the bottom of the vial. Use this intermediate dilution when calculating final dilutions as recommended below. Store the vial at -20°C or below after dilution. Avoid cycles of freezing and thawing.

Expiration: Expiration date is one (1) year from date of receipt.

Lane 1: Opal Prestained Molecular Weight Marker (p/n MB-210-0500).

Lane 2: human rERK1 Reduced [0.05µg].

Lane 3: ERK2 Reduced [0.05µg].

Primary Antibody: Anti-ERK2 (MOUSE) Antibody DyLight™680 Conjugated at 1.0µg/mL overnight at 2-8°C.

Secondary Antibody: Rabbit Anti-Mouse Antibody Peroxidase Conjugated (p/n 610-403-C46) at 1:40,000 for 30mins at RT.

Blocking buffer: Blocking Buffer for Fluorescent Western Blotting (p/n MB-070) for 1hr at RT.

Expected Molecular Weight: ~41kDa.
