Background:	F(ab') ₂ Antibody was generated by enzymatic cleavage and subsequent separation from the Fc fragment. Because of their smaller size, F(ab') ₂ fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab') ₂ fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab') ₂ fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab') ₂ Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays.

Purity/Specificity:	This product is a F(ab') ₂ fragment of an IgG fraction antibody purified from monospecific antiserum by a multi-step process which includes delipidation, salt fractionation, ion exchange chromatography and pepsin digestion followed by extensive dialysis against the buffer stated above. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Peroxidase, anti-Rabbit Serum, Cat IgG and Cat Serum. No reaction was observed against anti-Rabbit IgG F(c) or anti-Pepsin.

Application Note:	This product has been assayed against 1.0 ug of Cat IgG in a standard capture ELISA using ABTS (2,2'-azino-bis-[3-ethylbenthiazoline-6-sulfonic acid]) code # ABTS-100 as a substrate for 30 minutes at room temperature. A working dilution of 1:20,000 to 1:100,000 of the reconstitution concentration is suggested for this product.
