Background:	The SID1 transmembrane family member (SIDT2) is a highly glycosylated, multipass transmembrane protein that localizes to the lysosomal membrane. SIDT2 is highly expressed in liver, brain and kidney, with no or little expression in skeletal muscles, heart or other tissues. Little is known of the function of SIDT2.

Immunogen:	Anti- SIDT2 antibody was prepared from whole rabbit serum produced by repeated immunizations with an 18 amino acid peptide near the N-terminus of human SIDT2.
Purity/Specificity:	Anti-SIDT2 Antibody was affinity purified from monospecific antiserum by immunoaffinity chromatography. Multiple isoforms of SIDT2 are known to exist; this antibody is predicted to not cross-react with other members of the SID1 transmembrane family.

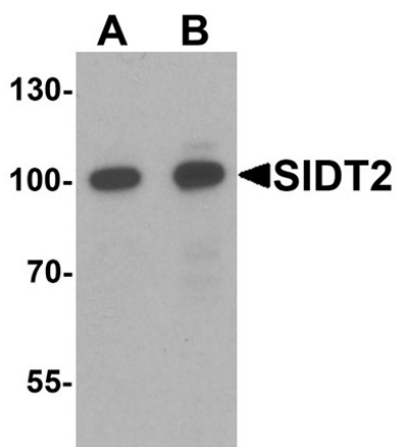

Storage Condition:	Store vial at -20° C prior to opening. Aliquot contents and freeze at -20° C or below for extended storage. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.
Expiration:	Expiration date is one (1) year from date of receipt.
