Immunogen:	PIP5K2B affinity purified antibody was prepared from whole rabbit serum produced by repeated immunizations with a synthetic peptide corresponding to the C-terminus of human PIP5K2B.

Purity/Specificity: Anti-PIP5K2B was affinity purified from monospecific antiserum by immunoaffinity chromatography. This antibody is specific towards PIP5K2B. A BLAST analysis was used to suggest cross-reactivity with Human, Mouse, Rat, Chicken, and Primate based on 100% sequence homology. Cross-reactivity with PIP5K2B from other sources has not been determined.

Storage Condition:	Store vial at -20° C prior to opening. Aliquot contents and freeze at -20° C or below for extended storage. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.

Expiration: Expiration date is six (6) months from date of receipt.

Western Blot of Rabbit Anti-PIP5K2B Antibody. Lane 1: Mouse Brain homogenate samples. Load: 10 µg per lane. Primary antibody: PIP5K2B antibody at 0.2 µg/mL for overnight at 4°C. Secondary antibody: IRDye800™ rabbit secondary antibody at 1:40,000 for 45 min at RT. Block: 5% BLOTTO overnight at 4°C. Predicted/Observed size: 54 kDa for PIP5K2B. Other band(s): None.
