Background:	Anti-KLH antibody allows for the detection of KLH, important for monitoring immune Response, infection and inflammation. Keyhole limpet hemocyanin (KLH) is a large metal-containing protein consisting of 400 kDa subunits that is frequently used carrier protein in immunization procedures. KLH is most typically conjugated to a small molecule, peptide, or protein thereby rendering the complex highly immunogenic. KLH has been used as a carrier for vaccines and antigens and as adjuvant treatment in regimens such as antimicrobial therapy. This Anti-KLH antibody has been conjugated to fluorescein.

Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.

Primary antibody: KLH antibody at 1:1000 for overnight at 4°C. Secondary antibody: HRP Goat-anti Rabbit secondary antibody at 1:40,000 for 45 min at RT. Block: 1% BSA-TBS overnight at 4°C. Predicted/Observed size: 350-390 kDa, 350-390 kDa for KLH. Other band(s): none.
