Background:	Secreted as part of the adaptive immune response by plasma B cells, immunoglobulin G constitutes 75% of serum immunoglobulins. Immunoglobulin G binds to viruses, bacteria, as well as fungi and facilitates their destruction or neutralization via agglutination (and thereby immobilizing them), activation of the complement cascade, and opsonization for phagocytosis. This product possesses the F(ab) region possessing the epitope-recognition site, both heavy and light chains of the antibody molecule are present. Anti-Bovine IgG (H&L) antibody is ideal for investigators in Immunology, Cancer, and Microbiology research.

Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Rabbit Serum, Bovine IgG and Bovine Serum.

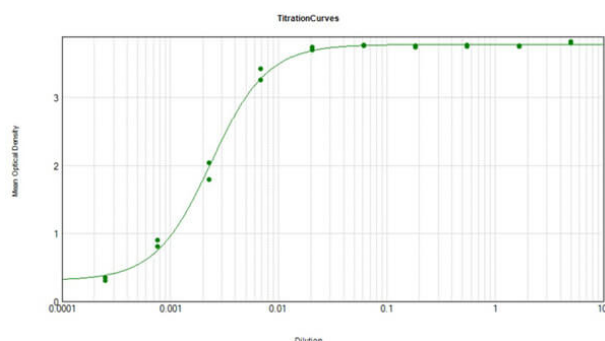

ELISA Results of Purified Rabbit Anti-Bovine IgG Antibody tested against purified Bovine IgG. Each well was coated in duplicate with 1.0 μ g of Bovine IgG (p/n 001-0102). The working dilution is 1:420,000. The starting dilution of antibody was 5 μ g/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using HRP Conjugation Stabilizer (p/n MB-076), Goat Anti-Rabbit HRP conjugated (p/n 611-103-122) and TMB substrate (p/n TMBE-1000).
