Background:	GluR2 Antibody detects GluR2. The ion channels activated by glutamate are typically divided into two classes. Those that are sensitive to N-methyl-D-aspartate (NMDA) are designated NMDA receptors (NMDAR) while those activated by α -amino-3-hydroxy-5-methyl-4-isoxalone propionic acid (AMPA) are known as AMPA receptors (AMPA). The AMPAR are comprised of four distinct glutamate receptor subunits designated (GluR1-4) and they play key roles in virtually all excitatory neurotransmission in the brain. The GluR2 subunit is thought to play a key role in forms of synaptic plasticity such as LTD. Therefore, GluR2 antibody is ideal for investigators involved in synapse plasticity study and in general in Neuroscience.

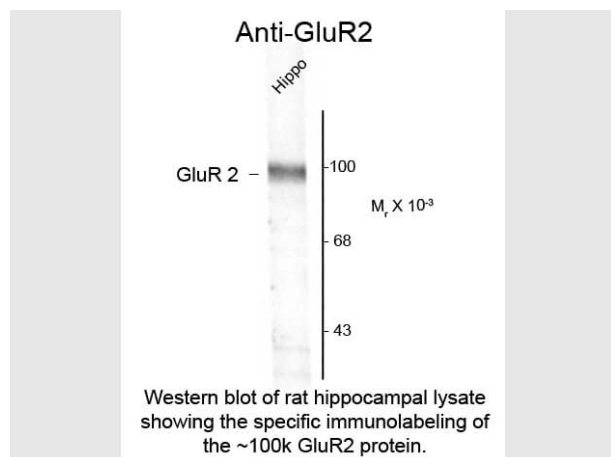
Shipping & Handling

Western Blot of Rabbit anti-GluR-2 antibody. Lane 1: rat hippocampal. Lane 2: none. Load: 10 μ g per lane. Primary antibody: GluR2 antibody at 1:400 for overnight at 4°C. Secondary antibody: IRDye800™ rabbit secondary antibody at 1:10,000 for 45 min at RT. Block: 5% BLOTTO overnight at 4°C. Predicted/Observed size: 100 kDa, 100 kDa for GluR 2. Other band(s): none.
