Because of their smaller size, F(ab) <sub>2</sub> fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab) <sub>2</sub> fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab) <sub>2</sub> fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab') <sub>2</sub> Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays. |
