Purity/Specificity:	This product was prepared from monospecific antiserum by immunoaffinity chromatography using Mouse IgG coupled to agarose beads followed by solid phase adsorption(s) to remove any unwanted reactivities, pepsin digestion and chromatographic separation. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Alkaline Phosphatase, anti-Goat Serum, Mouse IgG, Mouse IgG F(c) and Mouse Serum. No reaction was observed against anti-Pepsin, anti-Goat IgG F(c), Mouse IgG F(ab) or Bovine, Horse and Human Serum Proteins.

Application Note:	Fab')2 Anti-Mouse IgG F(c) Alkaline Phosphatase Antibody has been tested by ELISA and is assayed against 1.0 µg of Mouse IgG in a standard capture ELISA using pNPP p-nitrophenyl phosphate code # NPP-10 as a substrate for 30 minutes at room temperature. A working dilution of 1:4,000 to 1:20,000 of the reconstitution concentration is suggested for this product. Suitable for immunomicroscopy and flow cytometry or FACS analysis as well as other antibody based fluorescent assays requiring lot-to-lot consistency.
Assay Dilutions:	All assays should be optimized by the user. Recommended dilutions (if any) may be listed below.

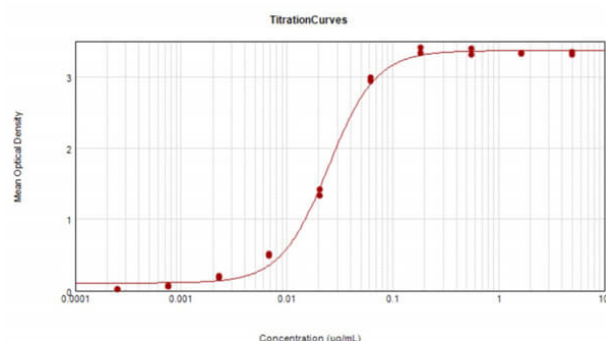

Shipping Condition:	Wet Ice
Storage Condition:	Store vial at 4° C before opening. DO NOT FREEZE. This product is stable at 4° C as an undiluted liquid. Dilute only prior to immediate use. Freezing alkaline phosphatase conjugates will result in a substantial loss of enzymatic activity.
Expiration:	Expiration date is one (1) year from date of receipt.

ELISA Results of F(ab)₂ Goat Anti-Mouse IgG F(c) Antibody Alkaline Phosphatase Conjugated. Each well was coated in duplicate with 10 µg of Mouse IgG F(c) (p/n 010-0103). The working dilution is 40,700. The starting dilution of antibody was 5 µg/ml and the X-axis represents the Log₁₀ of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC₅₀ is defined as the titer of the antibody. Assay performed using 3% Fish Gel/PBS (p/n MB-066), NPP ELISA Alkaline Phosphatase Substrate (NPP-10), and TMB substrate (p/n TMBE-1000).
