Background:	F(ab') ₂ Antibody was generated by enzymatic cleavage and subsequent separation from the Fc fragment. Because of their smaller size, F(ab) ₂ fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab) ₂ fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab) ₂ fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab') ₂ Anti-Mouse IgM Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays.

Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Biotin, anti-Goat Serum, Mouse IgM and Mouse Serum. No reaction was observed against anti-Pepsin or anti-Goat IgG F (c). No reaction was observed against other mouse heavy or light chain proteins.
