Background:	F(ab') ₂ Anti-Mouse IgG (H&L) Rhodamine Antibody generated in donkey was generated by enzymatic cleavage and subsequent separation from the Fc fragment. Because of their smaller size, F(ab) ₂ fragments offer several advantages over intact antibodies for use in certain immunochemical techniques and experimental applications. F(ab) ₂ fragments penetrate tissue samples and show better antigen recognition and signal generation in IHC. F(ab) ₂ fragments lack the Fc region and therefore do not bind Fc receptors which effectively lowers background staining. F(ab') ₂ Antibody is ideal for investigators who routinely perform flow cytometry, immunohistochemistry or IHC and other immunoassays.

Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Donkey Serum, Mouse IgG and Mouse Serum. No reaction was observed against anti-Pepsin, anti-Donkey IgG F(c), Bovine, Chicken, Goat, Guinea Pig, Hamster, Horse, Human, Rabbit, Rat, and Sheep Serum Proteins.
