<b>Background:</b>	Fab Anti-Mouse IgG (H&L) Biotin Antibody generated in goat detects Mouse IgG. This product possesses the F(ab) region possessing the epitope-recognition site, both heavy and light chains of the antibody molecule are present. Secondary Antibodies are available in a variety of formats and conjugate types. When choosing a secondary antibody product, consideration must be given to species and immunoglobulin specificity, conjugate type, fragment and chain specificity, level of cross-reactivity, and host-species source and fragment composition.

**Purity/Specificity:** This product was prepared from monospecific antiserum by immunoaffinity chromatography using Mouse IgG coupled to agarose beads followed by solid phase adsorption(s) to remove any unwanted reactivities, papain digestion and chromatographic separation. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Biotin and anti-Goat Serum. No reaction was observed against anti-Papain or anti-Goat IgG F(c).

**Application Note:** Fab Anti-Mouse IgG (H&L) Biotin Antibody has been tested by ELISA and dot blot and is suitable for immunoblotting, ELISA, immunohistochemistry, immunomicroscopy as well as other antibody based assays using streptavidin or avidin conjugates requiring extremely low background levels, absence of F(c) mediated binding, lot-to-lot consistency, high titer and specificity.

**Buffer:** 0.02 M Potassium Phosphate, 0.15 M Sodium Chloride, pH 7.2

**Preservative:** 0.01% (w/v) Sodium Azide

**Stabilizer:** 10 mg/mL Bovine Serum Albumin (BSA) - Immunoglobulin and Protease free

**Reconstitution Volume:** 1.0 mL

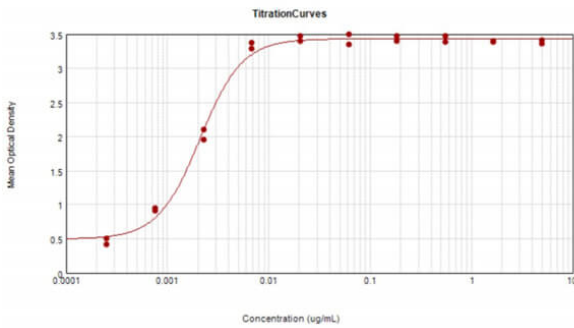
**Reconstitution Buffer:** Restore with deionized water (or equivalent)

## Shipping & Handling

**Shipping Condition:** Ambient

<b>Storage Condition:</b>	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.
<b>Expiration:</b>	Expiration date is one (1) year from date of receipt.

### ELISA

ELISA Results of Fab Anti-Mouse IgG (Goat) Antibody Biotin Conjugated. Each well was coated in duplicate with 10 µg of Mouse IgG (p/n 010-0102). The working dilution is 479,000. The starting dilution of antibody was 5µg/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using 3% Fish Gel/PBS (p/n MB-066), Streptavidin-HRP conjugated (p/n S000-03) and TMB substrate (p/n TMBE-1000).
