Purity/Specificity: Collagen is purified from rat tails via a multi-step process involving chemical soaking, extraction, filtration, and pH treatment. Extracellular matrix (ECM) - coated flasks are prepared under Laminar Flow Hoods, using sterile technique according to our Standard Operating Procedures (SOP). Representative production samples are collected and inspected for current product specifications. Collagen $\geq 90\%$ purity by SDS-PAGE.

Tested and found negative for bacteria and fungi with visual inspection after 14 days of incubated growth media.

Tested for the attribute of cell attachment and growth by utilizing an attachment-dependent human cell line in standard growth medium.

Surface Area: 75 cm².

Application Note: Primary benefits of coated plastics include enhanced cell adhesion, promotion of cell spreading and morphology, facilitation of cell signaling, support for specific cell types, and modeling tissue microenvironments. Collagen I is the most abundant protein in the extracellular matrix of connective tissues and plays a crucial role in cell adhesion, migration, proliferation, and differentiation.
