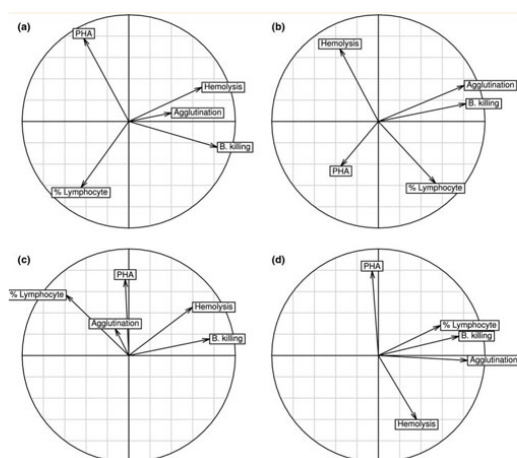

Agglutination

Correlation circles representing the association between immune measurements for each farmland-year sub-group of tree swallow nestlings studied in southern Québec, Canada, 2010–2011. (a) Intensive 2010: $n = 38$, 57.25% of variance explained by both PCs; (b) Intensive 2011, $n = 27$, 59.77%; (c) Extensive 2010, $n = 90$, 48.37%; (d) Extensive 2011, $n = 55$, 57.01%. Immune measures included the response to PHA (PHA), the bacteria killing capacity (B. killing), the hemolysis and hemagglutination scores and the percentage of lymphocytes. The horizontal and vertical axes represent PC1 and PC2 of a principal component analysis applied to each farmland-year sub-group. The lengths of the vectors indicate the strengths of the relationships. The size of the angle between vectors indicates the direction of the correlation: a small angle between two vectors represents a positive correlation; a 90° angle indicates no correlation and opposed vectors indicates a negative correlation. rabbit red blood cell solution (p/n R309-0050).
